





- To take upper-level Education courses, students must maintain a cumulative GPA of at least 2.5 (students with a cumulative GPA of 2.7 or higher have precedence for course enrollment).
- A minor in Education does not provide all requirements to be eligible to apply for entry into the Professional Year.
- A concentration in Education without field experiences does not provide all requirements for entry into the Professional Year. Please see Concurrent B.A./B.Sc./B.Ed. checklist if you are interested in the Professional Year leading to Teacher Certification.
- A total of 24 s.h., including a minimum of 12 s.h. of upper-level credit is required to complete a Minor, and a total of 30 s.h., including a minimum of 12 s.h. of upper-level credit is required to complete a Concentration. Students must have a minimum overall (cumulative) GPA of 2.0.
